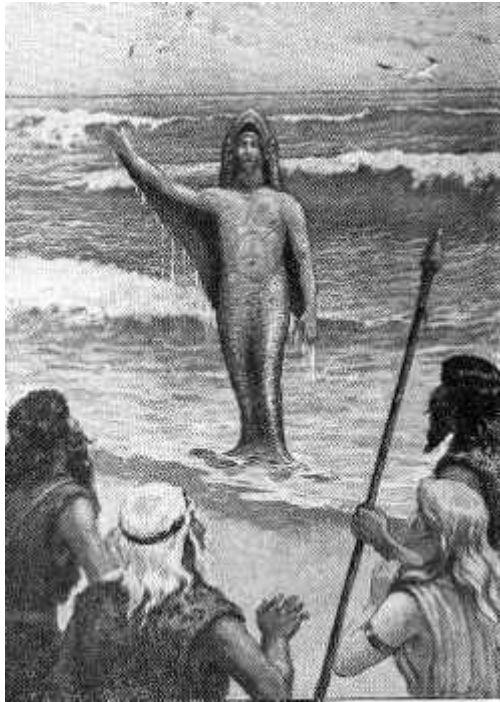

CURRENT CASE LOG:

On July 15 2010 a former police officer only identified as “Nick R” reported that while driving along the A10 going home one evening after work a light which was not

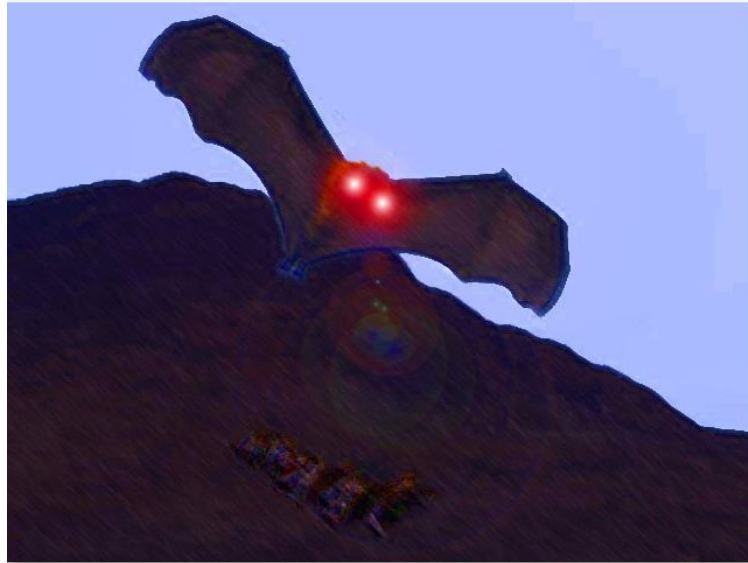
the moon, orange and oval in shape. He then drove into his parking space in Puckeridge (near Hertford England) and went into his flat (apartment) after about 10 minutes he went outside for a cigarette. His apartment was on Cambridge Court which backed on to fields. He saw in the twilight what he thought were kids messing about. He then saw the orange oval shaped light over the field and quickly realized that the short figures were not “children”. Suddenly the three child-like figures and the light disappeared without a trace. The witness lived near Stansted Airport. (1).

Sometime during August 2010 two witnesses, Megan and a friend, Kyra had traveled from Columbus Ohio to Ravenswood, West Virginia on business. While there they decided to make a side trip go Gallipolis Ohio, in order to visit relatives Megan had not seen for awhile.

Around 19:30 they decided to get dinner at a local restaurant and when they finished, Kyra needed to go to the store and pick up a few items that she forgot to pack. They then headed to a Wal-Mart that was near the restaurant. After they finished shopping they were walking to the car when Megan noticed a woman running through the parking lot. When she reached her car, she looked back in the direction of the store then hurriedly got into the car. Megan quickly looked in the same direction and saw what looked like a large bird flying above the roof of the store. It was difficult to see but when it swooped downward the parking lot lights would shine off of it. It looked like it was either oily or had shiny leather-like skin. Whatever it was, it had a wide wing span. She guessed it reached 8-10 foot across. It circled above the store for about a minute then just disappeared. They drove back to the hotel and decided to call it a night so they could get an early start on the drive home in the morning. She got ready for bed but thought she'd watch some television first, it was around 2200.

She must have dozed off fairly quickly because the next thing she remembers was a frantic knocking on her door. She stumbled out of bed and checked who it was. It was Kyra and she was obviously upset. She rushed into her room and said, ‘Its here!’ “What are you talking about?” asked Megan, a bit perturbed. Kyra said that she had been lying on the bed when she heard something in the hallway. She got out of bed, walked to the door and listened to what she thought was ‘scratching’ sounds. After a few minutes the sound stopped, so she went back to bed. Not long after she lay down she heard more scratching sounds but, from outside her window. Again she

got up and peeked through the curtains. This time something looked back at her. Their rooms were on the second floor in the rear section of the hotel and both looked out onto a small parking lot and a large field beyond that. She could see, what she described, as a 'bald ugly man with wings' who was looking directly at her with 'large bulging eyes that lit up bright red.' It was there for only a few seconds. It then spread its wings while running at the same time towards the end of the parking lot and lifted



off the ground like a bird.

The next morning they woke early, checked out and drove back to Columbus. Kyra didn't mention the incident from the previous night during the ride. In fact, she has still never said anything else about it. (2)

An anonymous witness in Baltimore, Maryland, woke up around 6:30 a.m. on December 24 2010 and was still in bed when a strange feeling and some difficulty breathing came over him. His eyes were closed when all of a sudden a pale white face on a man shaped head, two black eyes, two holes for a nose and a thin strip for a mouth appeared very briefly. The being emitted a sense of power and seriousness and it looked at the witness for about 3 seconds and then vanished. He was startled and not really scared as he had apparently experienced similar encounters before. (3)

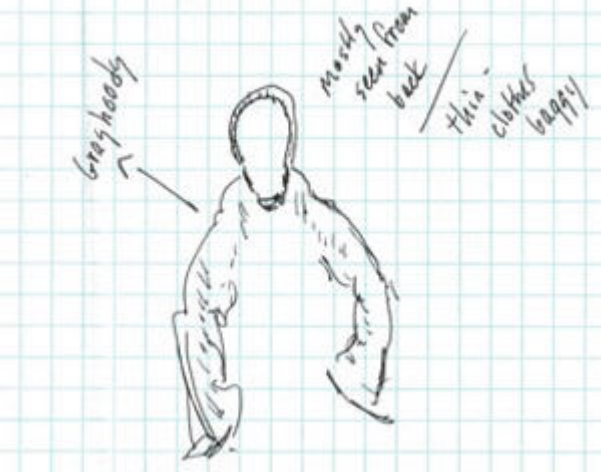
ANOTHER WINGED WEIRDO:

On December 30 2010, in New York City, New York (of all places) at around 1:30 a.m. a man was driving while his son and wife slept. Suddenly he pulled over and woke them up, he was hysterical and they didn't know what was wrong. He pointed to

the overpass and all they could see were these intense glowing bright red eyes. Not knowing what it was they started driving again and when they reached the overpass the 'thing' was still on it so the father (driver) decided to stop. Then the thing swooped down and landed on the roof of their car (!). The thing landed with such force that it dented the hood. It then proceeded to stand up on the hood and it was 6-8 feet tall, black and had wings.

They were all terrified at this point. The father then took out the cellphone and called the New York highway patrol and they laughed at him and hung up on him accusing him of making crank calls. According to one of the witnesses the creature still stood there until he took out his camera and photographed it with the flash on. Then thing then jumped off the car and took off, like it was afraid of the camera flash. (4). There are no details as to what became of the alleged photograph.

On January 1 2011 in Gaithersburg, Maryland, a witness was visiting his mother over the holidays. At around 7:00 a.m. he noticed that his dog smelled something and become quite uneasy. The dog would pace back and forth. The witness thought that perhaps an intruder might be outside and so he checked outside. At that time he saw a small figure about 5 feet tall, with hooded clothing. He went back and got his binoculars and when he viewed the entity it appeared to be "faceless."



The creature had short upper arms and long forearms. The creature tried to communicate with the witness through telepathy. It kept communicating "I am not witch, I am you." He then retrieved his 22 rifle. He did not point the weapon at the creature. The creature seemed oblivious to the weapon. At that point the witness put his hands on top of his eyes so as to shield them. The entity did the same. The entity then moved down a walking path and it seemed to "amble" rather than walk normally.

The dog watched the entity “attentively,” but did not bark. The witness lost sight of the entity as it “ambled” away from him. He said that the air was “real heavy” and the temperatures were quite warm for the time of year. Skies were mostly cloudy. (5)

On January 28 2011 in the village of Zarki Letnisko (Slaskie) Poland around midnight a 39-year old witness woke up to see a ball of red light floating in front of her in the bedroom. When she looked closely she could distinguish two black dots and a slash that gave the hovering sphere an ‘intelligent’ appearance. Soon the object dimmed, moved towards the window and disappeared. The sphere itself was semi-transparent. No other effects were noticed but the woman was terrified and was still thinking about the incident some time later. (6)

On February 22 2011 around 21:00, Brian P. was driving back to his home in Grove City, Ohio when he saw something very strange. He had just made a turn off Rt104 onto Borrer Road and was driving around a sharp turn when he saw something brown on the side of the road. He first assumed to be a deer since he has seen several on this road before but as he got closer it was too big to be a deer. The best that he could describe this “object” was that it looked like a big piece of brown shag carpet about 6 to 7 feet tall and about 10 feet wide. As he came close to passing this object on the side of the road it folded up like a rug being folded in half. The witness flinched and swerved out of the way because as it folded he thought it was lunging toward him and coming after him. He just sped up and kept driving home. He didn’t tell anyone what he had seen for several days. He later thought that it could have been a “Mothman” type creature, but he didn’t see any glowing eyes or wings. (7)

On February 22 2011 in Germantown, Maryland, the witness who usually slept on her stomach had fallen asleep on her back around 1:15 a.m. on this morning. Soon she woke up but could only open her eyes and only one at the time. She opened her right eye and just saw her fan and a flash of light, she opened her left eye and could see her television and again she saw a flash of light. Afterward, she tried lifting her body but couldn’t move and felt completely numb. She then heard unexplained voices on her right ear and couldn’t react at all, she said that she couldn’t even

'panic'. She could also hear something resembling a blender or a 'hovering' sound. She tried opening her eyes again and couldn't. Once the noise started to fade away, she was able to move. Her feet were cold and in a panic state she called her mother, the time was now 1:45 a.m. (8)



On March 5 2011 near Eagle Butte, South Dakota a employee at the Standing Rock Sioux Tribe (Reservation), a security guard at a casino was driving home alone after work when he began seeing red lights around 2340 resembling softballs and hundreds of them that were apparently spinning around the car this while driving south on Highway 20. The red balls, seemingly hundreds of them, kept pace with the vehicle for a couple of miles, they never did get very close to the car, and stayed at about 2 car-lengths away. After a couple of miles the car began to slow down, it slowed down to about 40mph and it wouldn't go any faster. Then the red lights just disappeared in plain sight. The car then sped up back to 60mph. He then reached to where a gravel road meets highway 63 (he had turned into highway 63 by now) at one of the wind block 'experiment stations' or soil erosion experimentation. At this point he began getting goose-bumps all over his body, a sort of tingly cold feeling all over his body. He then saw this 'thing' on the side of the road where the gravel road meets the main highway and before he knew it was by the car. It then reached in and touched the witness's head through the windshield and ran its hand down the witness back. His back got extremely hot.

He described the creature as having an oblong-shaped head, a really thin body, thin arms and legs. It was translucent and glowing like a very dim light-bulb, and he could see through it. Its eyes were the size of humans, and it had a really long nose and a huge mouth. Its arms were like sticks and it had its really thin stick-like arms stretched out, these also glowed softly. It was around 4foot tall. At this point the witness saw another creature on the other side of the road (left hand side) he described the second creature as 'horrifying' with a beast-like wrinkled face, squat in

appearance and about the size of a 'goat'. It was glowing reddish brown in color. As soon as he saw the 2nd creature it seemed to vanish. The first creature apparently remained by the vehicle for about 10 minutes as the tingly feeling would not go away. The witness eventually drove away and began to feel better as he approached a Bison farm about 15 miles from Eagle Butte. According to his wife he was in a very agitated state when he arrived home. (9)



Encounters with the blond and their kin, part 3, the nineties. (Due to the amount of material this issue will cover up to the year 1995).

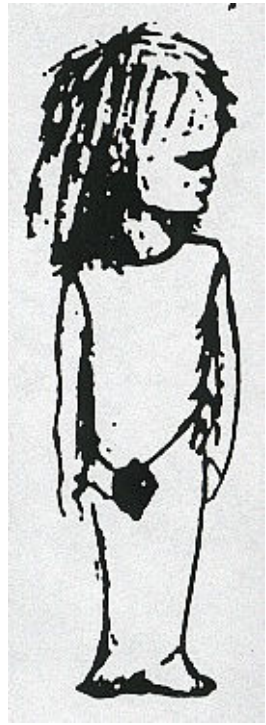
We now come to third part of our series, “Encounters with the blond and their kin”, in this section we will detail cases said to have occurred during the 90’s which in some way or the other describe this type of entity of being. The nineties was a decade of change, genocide, (Rwanda, Yugoslavia, etc), Operation Desert Storm, and of perhaps the beginning of a new phase in natural disasters (Hurricane Andrew). It also brought information from areas in the world which before there was few if any. The unprecedented wave of reports which began in Eastern Europe and the former Soviet Union in 1989 reached its peak during 1990–1992, hundreds of cases were catalogued by numerous UFO groups and investigators from those countries, but

unfortunately many or most remained un-translated and unknown to most Western researches, perhaps with a few exceptions. Whatever your take on the decade of the 90's we all must agree that the world would never be the same again, change was accelerated and it was irreversible.

We begin with the beginning or the 90's or the end of the 80's, whichever you prefer, the year was 1990 and it was a year to remember.

The first case comes from the city of Simferopol, located in the Crimean Peninsula of Ukraine. Before his encounter at an unspecified date in 1990, the witness, a teenager from Yalta, back in the summer of 1928 was loitering in the mountains of the Ai' Petri plateau, walking among the rocks and crags when suddenly he noticed a strange light emanating from a "karst" (shaft) on the ground. Being curious he approached closer and kept watching the unearthly light from coming out of the shaft. Some time later he was suddenly seized by fear and ran home. Now many years later (1990) the same witness (now obviously an adult) was in his bedroom at night when a very tall woman suddenly appeared in his room amidst a strange circle of light. The woman communicated by using telepathy and said, "Do you remember when you were a young boy, you saw the light from the place we live in the shaft?" The man was stunned since he had not told anybody about his previous experience. Before disappearing the strange woman told him that they lived in an underground city under the Ai' Petri plateau with an approximate population of 2,000. She added that they traveled in UFOs. (10) This case is part of the underground lore involving UFO bases and installations and of course ancient civilizations.

Beginning in the 90's encounters with entities at times described as 'looking like human-alien hybrids' or strange looking humans that did not quite fit in or acted very bizarrely were beginning to be reported more often and from almost worldwide locations. The following case is a curious example:



Sometime in 1990, late at night in the area of New Town, Edinburgh Scotland a man named Brian Wilson was working the late shift one night at a local Pizza Parlor when a pair of “rather small” adults, who had a somewhat “lopsided” look about them, approached the counter, raised their right hands, and announced; “Hi We’re Americans!” “What would you like?” Brian asked them, to which they countered, “What do you make?”

“Pizzas” replied Brian.

“What are pizzas?” enquired the supposed Americans.

The couple watched Brian intently as he prepared two cheese and tomato pizzas. All the while, the male “kept looking around the shop like he’d never been in a pizza parlor before.” Then the female pointed to a bowl of green peppers and asked what they were. By now, Brian’s colleague Doug had also noticed that there was something rather odd about the pair, and the two chefs exchanged glances of disbelief as Brian carefully explained what a pepper was. “Do they taste nice?” wondered the female. As the pair waited in silence for their pizzas (complete with green peppers) to cook, other customers came in and out of the shop as usual. Once their order was ready, the extraordinary Americans settled their bill. Each took a single bite out of their pizza then threw the remainder into the bin outside the shop.

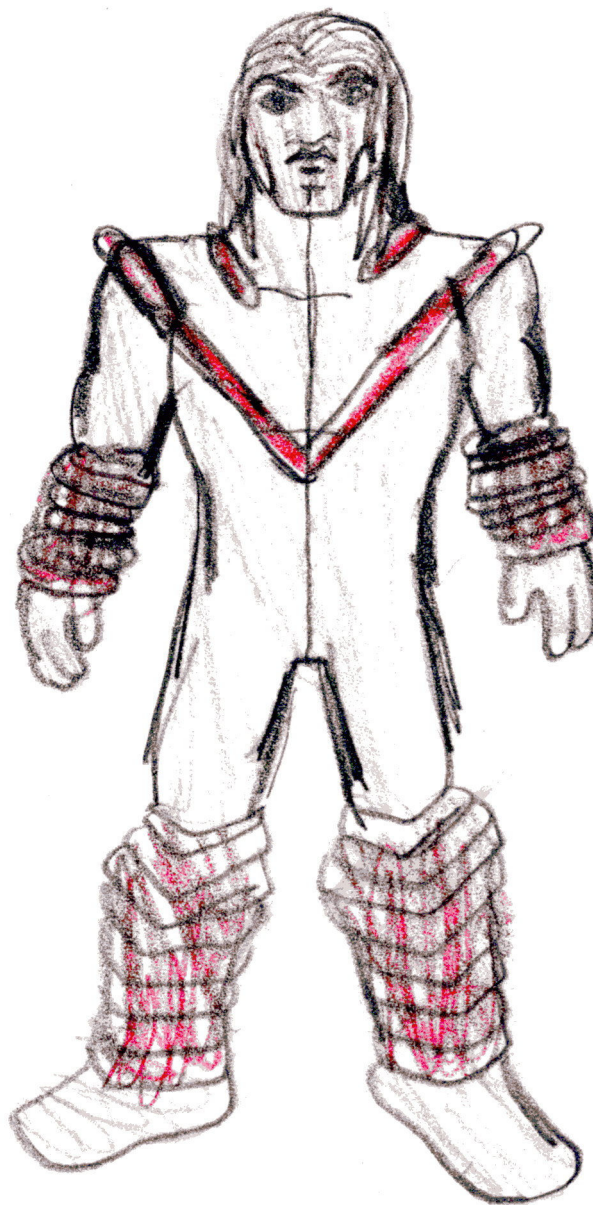
Brian entertained a suspicion that his visitors may have literally been from another planet. “I had read stories on the subject of aliens masquerading as human beings,” he told investigators. “These two individuals came across as acting as humans, but

not doing a very good job of it!” (11) Was this somebody’s idea of a practical joke? And for what purpose?

However most cases are more ‘conventional’ pardon the word, if there is such thing as conventional or normal when encountering something totally out of the ordinary that might change the way you view life and call all your belief systems into question, then we have tons of ‘normal’ encounters.

Once case in mind occurred in the spring of 1990 in the village of Krasnyie Stanki, Novgorod region, Russia. At around 18:15 a man walking along a stream in a heavily wooded area was getting ready to return back home when suddenly he heard a thin squeaky voice yell at him. He turned around and saw a very tall man with light hair and a tanned face standing very close to him. The man wore gray overalls with a wire running down from his neck. The man then invited the witness to come with him and was crossing a field when a strange object suddenly appeared, as if it had come out of the ground. It was a metallic whitish gray craft with windows, with bright yellow lights and emitting a buzzing sound. A door opened and both entered the object. Inside, the witness saw three other men and two women, who were all busy with instruments. The witness then entered a room and sat on an armchair by a window, outside he could see the roofs of the village. The witness suddenly became frightened and had a strange feeling. He begged to be taken back to his home. The object landed and the witness was let out, he could hardly walk and was very tired, he turned around and the object had disappeared. (12)

At times these entities behave very unlike the supposed “Space Brothers” persona that had become such a staple within Contactee circles and ‘Human like space brothers, here to save us from ourselves’ groups (need I say “Heaven’s Gate?”).



In March of 1990 around 22:00 an elderly witness experienced such an unsettling encounter. In the suburb of Barrio Borinquen, Atravesada, Puerto Rico at around 22:00 the witness was alone at home meditating when she suddenly found herself transported to her backyard, having no idea how she had arrived at such location. A silvery disc-shaped craft then approached from the mountains and began hovering nearby. From under the object a tall human-like figure emerged. The being then floated towards the witness. The figure was described as having fair white skin and blond shoulder length hair. He wore a white uniform with a bright red belt and red gloves and boots. He approached the witness and extended his hand. At this point the witness attempted to run but the being grabbed her by her arm and held her tightly. Four needle-like projections now emerged from the man's glove and were

then inserted into her arm. She felt powerless and “controlled.” She was taken to where the object hovered and was told telepathically that “they” would return to contact her again. She was then taken back to her house and released. (13)

As 1991 rolled around the unprecedented wave in the territories of the former Soviet Union and Eastern Europe had not eased. Either the masses from that vast region had suddenly come upon huge caches of Science Fiction books or material or something really extraordinary was happening throughout the region, from the Baltic to Eastern Siberia, weird encounters continued.



But first, meeting with a hybrid in Canada? Sometime in 1991 in Sault Ste. Marie, Ontario, Canada at around 23:00, the witness had gone to bed with her husband when all of the sudden in a ‘dream-like’ state she found herself in a white room. She could not see the sides and appeared to have tunnel vision. She was strapped down on a table and was struggling. She looked over to her side and saw a little girl or being staring at her from behind a window. The little ‘girl-being’ stared at her moving her head from side to side. The witness felt mental communication from an unseen entity telling her that the little girl was hers and they wanted her to name her. The little girl was very thin, her hair was pearly white, and it looked as if it was all at different length, and scant in some places. She wore an opalescent outfit, just draped over her body. Her arms and legs were thin. Her facial features were small except for her eyes, which were big and blue in color. She wanted to hold her but all of the sudden she ‘woke up’. She felt very sad and began to cry. (14)

Slovakian meeting:

On January 3 1991 in the city of Trnava, Slovakia (of course the former Czechoslovakia) at around 19:00, a 74-year old woman was watching television when suddenly the TV set went out and three men and two women appeared standing just outside her window. They were dressed in silvery close-fitting outfits and appeared to be very handsome and beautiful. She then heard a voice telling her to come outside but she refused. At this point the humanoids rose up and vanished into the sky. Her daughter also saw the beings. (15)

On April 1991 in the provincial capital of the Dagestan Autonomous Republic, Mahachkala, a female witness, initials Z. I. was home alone in bed when sometime between 03:00 a.m. and 04.00 a.m. she suddenly woke up to see a tall slender man in her bedroom. He was dressed in a tight-fitting black overall with a wide small strap and a cloak. She did not see his face. The humanoid said, "I have come for you, lets fly", "To where?"---asked the witness. The intruder then told the woman not to be afraid and promised to return her back home after the journey. She answered that she was not afraid. The 'alien' then said, 'So, let's go!' Next the woman saw what appeared to be stars, and remembered nothing more. When she awoke she thought that it had been a dream, but when she got up and looked out the window she spotted a shiny dot of light ascending into the sky from the direction of her house. The conversation had been telepathic. (16)

Bizarre encounter in Spain:

Late on the night of April 4 1991, near the town of Puerto de Alisas, Spain, the witness, Jose Saiz, was traveling alone on an isolated road and as he rounded a curve he saw what he thought at first to be a sheet floating in the air on the side of the road. Whatever it was it now floated on the center of the road and the witness slowed down and turned on the high beams. He was stunned to see that it was not a "sheet" after all, but a man-like figure. It was moving towards the witness, moving its arms very slowly as if it were swimming. Little by little it moved off to the right and feet first, descended to the ground. The now terrified witness could see that it was a tall man wearing something resembling a dark flowing tunic. It moved in strange leaps and bounds as the witness noticed that it had a very pale face and a pointed chin. As the witness drove by the figure, he looked more closely and was able to see more details.

The entity had a long bony pale face, somewhat resembling that of a corpse. Its whole face and body appeared to be illuminated by a dim glow, bluish reddish in color. It had long straight hair almost white in color and was shoulder length. Its hands and feet were long, bony and strong in appearance. He was apparently barefooted. The humanoid was easily over 2 meters in height and wore something on his forehead resembling a diadem or tiara. The humanoid facial expression was that of extreme resigned sadness and fear. This frightened the witness who as he drove by the figure saw it bend down in an almost mechanical fashion. Saiz then attempted to accelerate the car but it had inexplicably lost power, however it suddenly accelerated and the witness drove away leaving the bizarre being behind. The witness was left under the impression that the humanoid remained on the road as if waiting for something or someone. (17)



On August 29 1991 in the small village of Kremovo, Mihailovskiy area, Primorskiy region, in the far East of Russia, four young people were camping in the forest, three men, Dmitriy Cherney, Alexander Senchilo, Anatoliy Cherney and a young woman named Tatyana Timchenko. At around 20:27 the young group was roasting potatoes around a bonfire, which they had set up about 1 km from the road. Suddenly Alexander looked at his digital electronic watch and noticed that the hands were moving the opposite direction. Suddenly there was a blinding flash of light resembling that of a photo lens. The group looked around stunned as their dogs ran away yelping. At this point all the witnesses were paralyzed. Soon a lilac-colored

globe appeared hovering at about 20–30 meters from the witnesses. It appeared to be separated into two sections; one section seemed to increase in size while the other section vanished. The larger part increased to a size that could allow adult men to enter and walk out. Unexpectedly a “woman” stepped out of the globe. Her body seemed to be made out of “knitted” silver light. Her loose hair fell on her shoulders. The stranger was similar to a human female, but her hands were somewhat different (how?). The witnesses were terrified but could not escape since none could move. The woman then approached Tatyana and in a strange squeaky voice asked her to take her clothes off and give them to her.

Strangely when the alien woman began speaking their tape recorder became activated. Terrified, Tatyana refused the woman’s request. The woman then turned around and returned to the globe. The light on the globe dimmed and it then ascended into the sky and vanished. Now the witnesses were able to move again. A strange detail emerged later, apparently Dmitriy did not see the alien woman, only heard Tatyana talking with an invisible someone and soon began speaking in a strange tongue that his friends could only compare to French. Scorched trees and wilted leaves were found at the site by researchers. (18)

A strange incident was reported on March 11 1992, in the quaint little village of Bellomonte, Guaynabo area in Puerto Rico. At around 18:30 the middle age female witness who had previously experienced a vision and telepathic communication with unknown entities, was sitting alone on her rocking chair on the rear patio area of her home, when suddenly she felt a strong presence near her, she looked around and nearby stood two very tall muscular light skinned men wearing black tight-fitting outfits that covered everything except their faces. They proceeded to tell the witness (via telepathy) to remain calm; these two men were accompanied by two shorter humanoids with large egg-shaped heads, yellowish skin, wide lipless mouths, and eyes resembling two large dark slits. These two wore brown loose-fitting outfits. The two short beings appeared to be in charge of the situation and were intent in inspecting the terrain and plants, constantly murmuring between them in a strange language. The tall more human-like entities communicated to the shorter humanoids wanted her to plant different types of trees and flowers in her garden. (To what end?) The witness said that she felt more comfortable dealing with the human-like beings than with the short creatures. But there appeared to be a definite cooperation

between the two types. (19). Have we here apparent cooperation between different 'races' of beings or humanoids? Who is really in charge?

The weird levels of reported events continued to increase as 1992 moved on. Sometime in April 1992 in Tijeras Canyon, New Mexico at around 21:40 Sue Strickland was traveling north through the canyon when she saw something resembling a "mini jet" streak into the canyon from behind her, preceded by a fireball of light about 2' in diameter. The ball of light streaked by following the paved road, the mini jet apparently following it, near an outcrop the mini jet suddenly stopped and hovered silently; it then tilted 45 degrees and maneuvered over Strickland's vehicle. After hovering over the truck for a minute or two it accelerated and disappeared around the next curve. The witness drove up and saw the craft on the road just ahead. She could see that it was a jet-like vehicle, slightly larger than she thought, with a curved canopy. She could see two figures, one inside, the other walking towards the rear of the object. As she sat looking at the object and figures, she suddenly found herself inside the object. She stood in an aisle with a short wooden bench on both sides. She attempted to walk towards the front of the object but was commanded to stop. After saying something to the pilot, a short thin, man-like figure approached her. He was bald and was wearing a blue coverall with gold embroidered epaulets on his shoulders. Apparently this being attempted to implant a hypnotic suggestion in her mind about forgetting the incident, but it did not work. He seemed surprised, and then the pilot told him to 'get rid of her'. Sue's next memory was of sitting in her truck and seeing a streak of light out of the corner of her eye. (20).

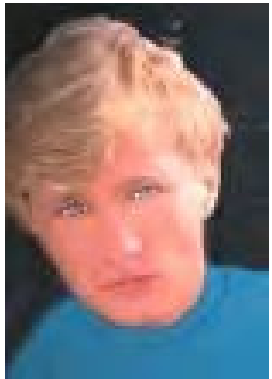


In the summer of 1992 a strange and disturbing event was reported from Beckley, West Virginia. At around 03:00 a.m. the witness was just pulling out of the parking lot of a local mall when he noticed a blond haired woman that appeared to be 8-months pregnant running alongside of the road. He pulled up next to her intent in assisting her when the frantic woman jumped into his car and began screaming, “Get out of here! They are after me!” “Leave me alone! Get away! They are after me!”

As he drove away with the screaming woman next to him he noticed what appeared to be headlights following his vehicle. He attempted to outrun the lights but was unable to, at one point he slammed the brakes and the lights flew over his car then hovered in mid-air yards above them. The woman screamed again and told the witness to drive to a nearby decrepit and apparently abandoned house. There she left the vehicle and ran into the house. The lights hovered overhead for a second and then shot away. After awhile the witness recalled some strange details about the woman, he described her as good looking, with a petite face, not swollen like a normal pregnant woman. She wore a bright green blouse that seemed to absorb light and her slacks were wrinkle free without any creases. A week later he returned to the site of the house and found out that it had been abandoned for years. (21) Of course there are more questions than answers when it comes to this case. Who was the strange woman? What were the lights? Was she an escaped hybrid?

In July 1992 in Nashua, New Hampshire, the main witness was coming home from a night out with friends and as she drove down her street she stopped for a speed bump and saw a huge craft hovering at the back of her neighborhood. She felt in

some kind of trance-like state and went home and straight to bed while the craft still hovered outside. The following two consecutive nights her daughter said she saw a “lady” in the witness’ bedroom. She described her as looking like someone “from Star Trek” beautiful with long blond hair and blue eyes, she wore a kind of uniform with a triangular symbol on it. The girl said she tried to wake the witness up but she wouldn’t wake up. (22)



Late in August 1992 in the Cannock Chase, Birmingham, England, one late afternoon, in order to escape the oppressive heat, the witness had gone on a walk in a wooded area at a local park. As he neared a small clearing he noticed what seemed to be a foggy mist in the center of the clearing. He then noticed a glowing light within the mist. Curious he approached the mist and was able to see a metallic shining object with orange, red, purple and green pulsating lights within the mist. As he stepped closer he felt compelled to look towards the woods. Two men dressed in tight-fitting light colored overalls were walking toward him; each carried an object resembling a worker’s toolbox and a thin long object, which emitted a thin laser-type light. The men were described as young looking with black hair and identical to each other. The men approached the witness and asked him several questions and then told him that they were there to take samples. After several minutes of conversation the witness suddenly noticed a slight glow appearing around the figures and began to feel drowsy, he sat on the grass almost feeling hypnotized by the men. The two men then walked into the cloud of mist and vanished. The witness then walked back to his car and fell asleep. The witness recalled that the two men had “olive” complexions and appeared very athletic. They both wore a thick belt around their waists. (23)

1993 was a very important year, so far, as encounters at a location not known for having this kind of nonsense occurring at regular intervals. With only few and far between reports of anomalous encounter the state of Israel felt perhaps safe from intrusions of flying saucers and anomalous entities, they were in for a rude awakening.

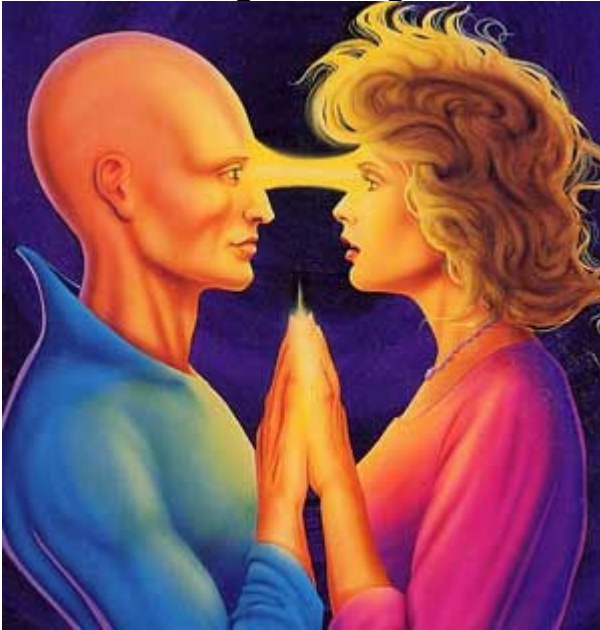
But before a brief summary of an incident that occurred sometime in 1993, in the village of Pinaya, Peru. At around 19:00 several local peasants reported seeing two very tall man-like beings in shiny gold colored metallic suits enter the village and walk around the Plaza. The beings were very athletic looking and had glowing yellow skin. They took short steps as they walked and moved their arms normally. At one point both entered a local church, looked around briefly and then left towards a nearby hill. (24)

In another interesting and a bit involved account, also sometime in 1993 in the province of Queensland, Australia (the witness requested anonymity as far as location) the main witness, Margaret first remembered seeing a very dark form with red glowing eyes; her son also reported seeing the figure at times. They also reported having trouble with small dark “energy forms,” like small shadows that darted around their rooms. According to the witness her son’s cousin also saw the shadowy forms and refused to sleep in the room, they appeared to be of a negative disposition. Around the same time her 3-year old daughter reported that a “tall woman” had come through the window of her bedroom. She wore a body suit and boots. She said the lady gave her cake and pink milk to drink in a large goblet, and spoke to her for some time. Margaret does not know what was said, she had been in a different room of the house at the time. Her daughter insisted that the lady had come straight through the large glass window.

Her daughter had previously experienced several NDE’s (near death experience) or OOBES (out of body experience) incidents. On another occasion, her daughter saw a woman in a long white robe with a golden belt or sash around her waist, and she said she glowed and had “sparkles” coming from her; she walked towards some trees and vanished. She saw her quite clearly. Just prior to this incident Margaret had been on the phone and had see a tall woman that appeared to have shorts and a white t-shirt on, run past her at a very fast pace. She put the phone down and ran to the back of her property but could find no one. It would have been impossible for someone to

go past that speed as there were concrete tank blocks in her path and the person would have had to maneuver around a sharp 90 degree corner. (25)

High Strangeness comes to Israel



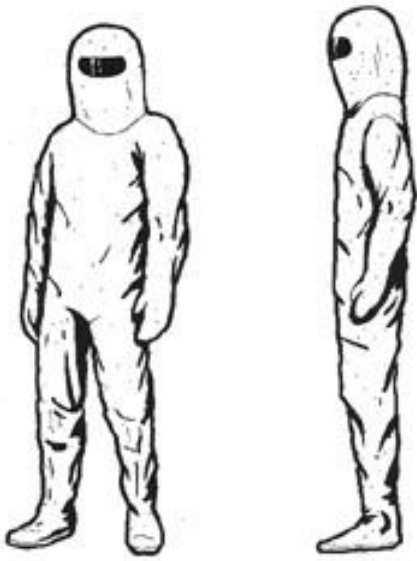
The first reported event in Israel appeared to have been the vanguard of things to come and reportedly took place in Kadima (scene of future events) Israel on March 3 1993. Early in the morning Shoshana Yahud woke up after hearing a loud bang. She was afraid to go downstairs to check on what it was, so she lay in bed thinking that she could wait until daylight to check, when she saw something coming through the wall. It was a man or a being, with an oval shaped face, he had large glittering eyes and his nose was very small like a dog's. The strange humanoid apparently left in the same manner. The day after the encounter Shoshana experienced bad headaches. Later she went outside to get some air and put some laundry on the line when she was surprised to find a perfect circle, four and one half meters wide impressed into the ground. (26)

On March 20 1993 again in Kadima Israel, at 6:30 a.m. Ziporet Carmel woke up earlier than usual and went to the kitchen. As she got there she noticed that the room was bathed in a strange light. She went to check the grounds and as she walked around the storage shed she noticed what appeared to be a large fruit silo on a nearby field. As she took a closer look she noticed that she silo-like object was silver colored and square in shape. It had what appeared to be 18 glowing square windows along its side. Five huge beams of a powerful light shone from its top into the sky. Suddenly what appeared to be a second section of the object materialized doubling it

in size. Then a seven-foot tall man-like figure appeared near the object. The dogs reacted in a violent manner upon seeing the figure. The figure wore a metallic overall and what appeared to be a sombrero-like headgear with a veil that covered his face completely. The figure and the witness then stared at each other for about 30 seconds. Ziporet then quietly whispered, "Why don't you take off your hat so I can see your face.?" She then heard a clear voice inside her head that spoke in Hebrew telling her that, "That's how things were." Ziporet then felt compelled to go back to her kitchen. Later during a search of the field numerous ground traces were found and an unknown smelly substance that made people sick with nausea was also recovered at the site. (27)

The otherworldly intruders were not done with Kadima yet, on March 30 1993 at around 03:30 a.m. another woman, Aviva Carmel felt drawn to leave her bed and go outside. There she witnessed a silver craft land in two stages, first the front touched down, then the rear. She estimated the size and shape of the craft to be similar to an "orange storage tank" or a fruit silo, about sixty feet in circumference. She approached the craft to investigate and from about twenty feet away saw one of the crew. He was 2.5 meters tall and wore silver foil coveralls that clung to the body like a second skin. He wore a helmet but its tinted visor prevented her from seeing the face. The next day Carmel ventured into her backyard and saw the imprint of the craft, it was a circle 22 feet in diameter formed of living vegetation. Plant life outside the imprint had died. (28)

Still in Kadima, on March 31 1993 late at night, the neighbor of the previous witness felt her house tremble during the night. When she opened her eyes she saw "a bald giant, 7 to 8 feet tall, with round, yellow eyes and a small flat nose, dressed in gray metallic, overalls," standing next to her bed. "Don't be afraid. I will not harm you," she heard in her mind and saw the being gliding through the room. The next morning, 2 more circles were found, 20 and 11 feet in diameter and "pressed down by a centrifugal force." (29)



Again in Kadima, Israel, sometime in late March 1993 at night, a woman, only known by the name of Ophra reported being lifted into a hovering “spacecraft” by a ray of light. She could not struggle or resist in any way. She was lifted into a room entirely composed of a brilliant crystalline material. She communicated in English telepathically to a crew of three, one of whom was clearly the leader. The three were tall, very fair, blond and handsome, something like a Nordic God or a “California surfer.” The leader informed her that they were known as the “light people.” No other information is known about this event. (30)

After a break of about of month (as far as its known) in Israel things started heating up again in May.

Sometime in May 1993 in the hamlet of Rishon-le-Zion, Israel, one night the witness Batya Shimon reported encountering an eight-foot tall humanoid “with fascinating blue eyes,” dressed in silver coveralls that appeared in her bedroom and glided through her apartment. The incident repeated itself the next night, when Batya followed the creature and saw a “mushroom shaped craft, surrounded by searchlights” hovering outside. A hatch opened which looked like dark glass, and 2 beings stepped out. The next thing she felt was a pressure on her shoulders. She was then blinded by the bright light---and found herself back on her bed, with one of the giants standing next to her, the other one further away. “Don’t be afraid,” she heard inside her head. She could not reply, since she was paralyzed. Her husband was sleeping deeply next to her. The beings glided, surrounded by fluorescent light, out of her bedroom window, back to their craft. The next morning Batya found a powder that was found to contain mainly cadmium on the floor of her flat (apartment) (31)

However on May 13 1993 the action reportedly returned to Kadima Israel again when at 02:00 a.m. on that morning the witness, Danny Rotem, following a restless night, felt compelled to get in his car and drive. He drove near the forest and saw an object shaped like a large egg on the ground. He left his car immediately and then a tiny being, maybe a meter and a half tall appeared. The being told Danny, "We were waiting for you." The humanoid floated in front of the witness as he walked to the ship. Rotem does not remember how he got inside the object but realized that inside the object it seemed much larger, by far, that it could have been, judging by its outside dimensions. In the middle of the room was a pillar with an enormous pedestal. There were 13 aliens in the room but only two led the witness to a side chamber where he was made to lie on a very comfortable sofa. He was told telepathically not to worry, "That he was on a mission, you'll know what is in time." Then they made an incision on his left wrist. His next memory was of being in his car traveling back home. (32)

On May 30 1993 in Bourgata, Israel one of the most unnerving encounters of the Israeli wave occurred. The witness, Hannah Somech woke up at around 03:00 a.m. when she heard her dog barking. She got up and went downstairs from her bedroom to the kitchen and looked out the garden through the glass door when she saw her dog literally flying through the air and slam against a wall. Shocked and terrified she bravely opened the door but was confronted by an invisible wall or force field; she could not go any further. Then she saw an eight-foot tall giant in bright coveralls. A 'thief' she thought. "You think I am a thief?" she heard inside her head. "What did you do with my dog,?" she asked furiously. "He disturbed me, as you do now," the giant spoke telepathically, without moving his lips. "I could crush you, but I don't want to. Just leave me alone, I am busy." The witness ran back to the bedroom to wake up her husband, but when both came down, the giant had disappeared. In the garden, they found huge footprints, 1 foot, 4 inches in length. Later, circles appeared too, again covered by the reddish cadmium based liquid. After the encounter Hannah suffered severely from fatigue, headaches and muscle pain. (33)



At the end of May 1993 back in Rishon-le-Zion, Israel a strong light from the kitchen window awakened Batya Shimon (involved in previous similar encounters). Looking out, she saw a large mushroom shaped object with a clear door, approaching from the sky. A light was directed at her shoulder and it felt like a strong punch. Her next memory was of being back in bed watching a tall humanoid wave his hand slowly above her husband's head. He telepathically told her to calm down. He told her they were not here to harm her. While the visitor was in the bedroom, another was touring the rest of the house, not so much on foot as floating upright---his legs did not move. His face was covered in a thin haze that obscured details somewhat, but Batya recognized both humanoids as the same race of guests that she had seen previously. This time, however, she noted more details. Their hands were human, but their skin was as light as an albino's. Their clothes were also white but they "shone like neon and were skin-tight." Suddenly the second visitor appeared opposite her bedroom door, just inside her son's bedroom. He gesture his comrade to come and have a look what he had found. The first being floated to the boy's room and both stared transfixed at the boy's aquarium. The visit lasted just a couple of minutes when a light shone through the kitchen window and they disappeared into it. The next morning all the doors were again opened and sand-like material (previously found), this time described as smelling like sulfur, was spread over the shelves. (34)

A strange incident reportedly occurred off the coast of the Sharon region of Israel in the summer of 1993. One afternoon a man from a local fishing village was fishing about three miles offshore when he suddenly noticed a huge disc-shaped

craft descending towards the ocean, before he could recover from the amazing spectacle, hug eight meter tall waves battered his boat. He was badly injured but somehow managed to make it back to port. At the hospital it was revealed that he had suffered a broken back. (35)

Also in the summer of 1993 in the village of Holon, Israel, there was a vague report which indicted that several humanoid giants wearing silvery metallic coveralls visited a woman named Clara Kahanov at her home one night. (There is no additional information on this case). (36)

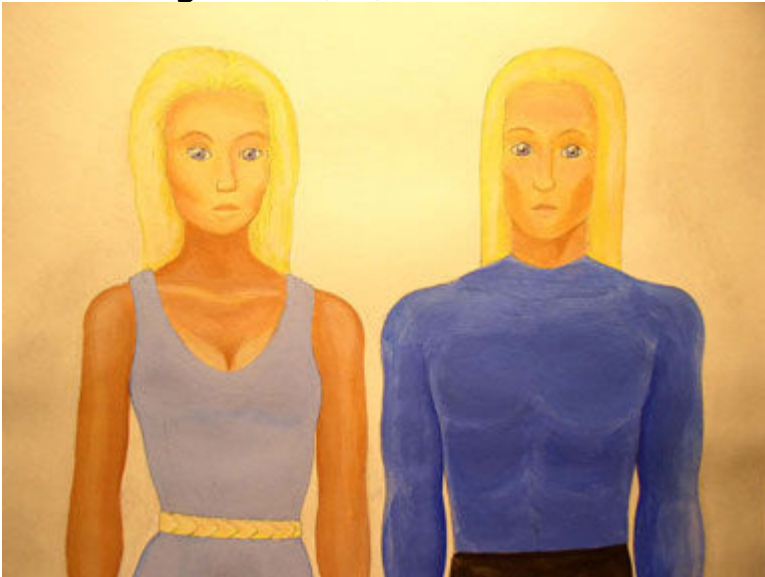
There was one last report from Israel in 1993, in the village of Kfar Saba, on an unspecified date on June, late one night a witness had gone into her bedroom to sleep when she encountered what appeared to a three dimensional entity standing less than a meter from her. The being was very tall and was wearing a silver/green "space suit." It emitted white beams of light from its waist area. The witness felt an intense energy emanating from the beams of light, which traversed her whole body. She described it as a joyful feeling. The being then took several small steps and vanished in plain sight. (37)

We move on now to 1994 as the strangeness continued on, unrelenting and uncompromising.

In February 1994 at a location called Wythenshawe, Manchester, England, a 49-year old man named 'Ted' was awoken around 2:30 a.m. by a blue light which illuminated the whole of his bedroom. Upon trying to get out of bed, he found it impossible to move, unable even to turn his head. Then from the right hand side of the room he saw two beings come into view. He described the beings as very tall with long blond hair, blue eyes and looking exactly the same as any normal human being. He then saw on his left another being come into view looking just like the others, he thought this was odd as his bed was pushed against the wall on that side which meant it had been moved while he slept or the being was standing right through the bed.

The beings proceeded to remove Ted's bedclothes and began examining his sexual organs. The beings then told him without moving their lips, "that he was not to be afraid". The next thing Ted remembers was his wife who was asleep in another room getting up and going to the toilet and one of the beings telepathically saying to the others, "I will see to her", but this being was stopped by one of the others (who seemed to be in charge) saying "no let her be." All three then continued with their

experiment on Ted, after a few minutes had passed the being in charge said, “this specimen is no good,” they then placed the covers back on Ted and left his line of view. A few moments later Ted found he was able to move although sluggish and shaking. He then went to his wife to tell her of his experience. Ted still does not know how they left the room or how long they had been there. But what is interesting is that Ted, a few weeks prior to this episode had undergone a vasectomy and directly after the episode developed a rash in the area he claims they had touched him. On seeing a doctor Ted was sent to a specialist who could only diagnose an unknown fungi rash. Ted although haunted by this episode in his life now recovered from his rash but still has nightmares and is unable to sleep in a room on his own and without the bedroom light on. (38)



Also in February of 1994 in a completely different part of the world, in the community of La Perla, Camargo, Chihuahua state, Mexico, one night the witness, a man called, Miguel Angel de la Torre, reported seeing a large silvery disc-shaped object that flew low over his head at an altitude of about 20 meters illuminating the ground below in a brilliant white light. On a later night he was visited in his bedroom by a blond haired humanoid about 1.80m in height, wearing a white tunic-like garment that stared at him intently. De La Torre did not report any period of missing time. (39)

On May 20 1994 in Frigole, Lecce, Italy, at around 5 minutes after midnight, soldier Claudio Mucignat was making his rounds at a local Army installation when he noticed a small laser-like point of light by a nearby parked armored vehicle. Thinking that it was a soldier smoking a cigarette he approached the area in his military

vehicle. As he neared the site, his vehicle headlights illuminated a 2-meter tall human-like form, wearing a dark non-reflective outfit that appeared to move towards him in a strange 'undulating' fashion. Terrified, Mucignat attempted to fire his weapon but it malfunctioned. Suddenly a red beam of light shone on him apparently causing instant paralysis. After about 5 to 6 minutes he recovered his senses but the strange figure and the lights had disappeared. (40)

In the summer of 1994 in Santa Fe, New Mexico, the witness, Shona Bear Clark suddenly awoke at 03:32 a.m. to see her bedroom illuminated by a bright light. She looked down at her foot and realized that a piece of flesh about 1" deep and 3" long was missing. The inside of her foot was silver in color, but there was no blood. She then realized there were two men standing beside her, one on each side of the bed. They were standing right through the bed. They had blond, shoulder length hair, blue eyes, and appeared to be about 50 years of age. Their skin was a bronze color, as though they had good tans. They wore robes; one was wearing red & white with gold roping around the collar, the other robe was blue and white, with gold roping. The man in the blue went over her foot with his hand and said that she was totally healed. The other man put his hands on each side of her head without touching her and said, "We will be back when you need us." Then they disappeared. Her foot had returned to normal, but the peculiar light remained until six in the morning. (41)

On December 22 1994 there was a return trip to Israel, more specifically to the village of Yatztiz. The same night that two young brothers videotaped a strange object over the eastern sky and strange tracks were found near their home, two men, Danny Ezra and Herzl Casatini, at around 21:00, were relaxing at the latter's home when they suddenly heard an explosion that shook the house. Herzl opened the door to investigate, and was confronted by a nine foot tall giant wearing metallic coveralls, standing in front of the house, a 'glowing haze' blurred the giant's facial features. Herzl slammed the door and motioned his friend to the window to look. Danny stared at the giant for 15 seconds. Herzl called the police, and when they arrived the giant had vanished, but strange footprints & tracks were found in the area. Fruit trees, which were growing beside the giant tracks produced weird genetically, altered products the summer following the incident. (42)

The year 1995 was mostly known for ushering in the modern day "Chupacabra" onslaught, starting in the Commonwealth of Puerto Rico and then spreading out throughout most of South America and other places worldwide, reports are still

coming in the 21st century. However the blond and their kin were still around and active as usual, they have never left.

We further visit Israel sometime in mid-March 1995 in the village of Ramat Hasharon, one night a young woman watched a giant male figure wearing a tight-fitting silvery metallic outfit in her garden. Plaster casts were taken of huge footprints left on the scene. These showed similarities to other prints found at previous locations. (43)

A very peculiar, if not humorous, incident was reported on May 19 1995 near the town of Pasiano, Italy. At around 23:15 a professional stopped his car to watch a metallic top-shaped craft with a transparent section hovering over the road. Inside he was able to see up to 25 apparently naked smiling humanoids standing around. These were about 4-foot tall with large elongated heads, topped with short cropped dark hair. The humanoids appeared to be smiling and had normal looking eyes and noses, and large pointed ears. They had long dangling arms with large hands. The craft took off after a few minutes. That same evening witnesses watched moving lights in the sky in the same area. (44)

A strange encounter was reported in Portland Oregon, one night on June 1995 (exact date unspecified). The two main witnesses had attended a friend's birthday party. The moment they arrived they noticed a strange man sitting on the sofa. He was tall, largely built, approximately 250 lbs. He had short very black hair, pale skin; his eyes in some lights were dark brown, sometimes greenish. His face was also as heavily muscled as his body. His clothing was of a black, shimmering material. He appeared to be accompanied by an attractive, older woman of about 80 years of age. She had long white hair and was wearing 'New Age' jewelry. He arose from the couch only once during the course of the party to speak with someone briefly. Many people in the party felt a strong presence and magnetism coming from the stranger. One of the main witnesses felt that the man was studying her, or that he was pretty much studying everyone there. A curious feature was noted about the strange man, that unless you faced him directly, you could not understand a word he was saying, even if you were at a slight angle to him, all you could make out would be unintelligible nonsense (gibberish). Another strange thing was that the witness was sure she was introduced to this man she could not recall the name he gave her.

The morning after the two main witnesses had met the peculiar stranger at the party, their son was out playing in the backyard when he saw a tall, large man, with

muscles on his face, wearing shiny black clothes that appeared halfway across the neighbor's yard to the west of the house, apparently out of thin air. He walked up to the gate and shook it a few times. Then after staring at the child until the child became very uneasy, the man turned and started walking away the same direction he had come from, and then once again disappeared in plain sight. (45)

On July 7 1995, in the city of Halmstad, Hallands, Sweden, at around 04:10 a.m. a husband and wife reported being visited in their bedroom by a short looking human-like individual with short cut blond hair and wearing a silvery or aluminum like coverall. The stranger communicated briefly by using telepathy and the disappeared. The husband and wife duo reported further contacts (no further information available). (46)



On October 15 1995 there was an incident in a country where information about UFOs and other anomalous phenomena was almost non-existent and very much controlled by the government.

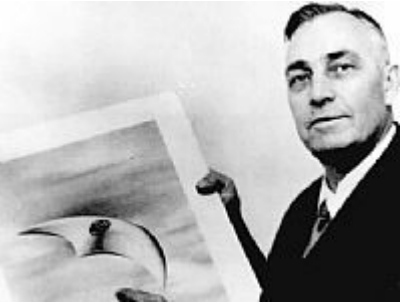
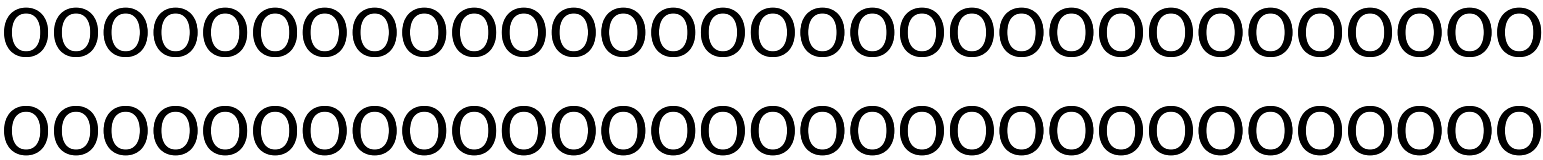
In the village of Torriente, Matanzas Province, Cuba, 74-year old farmer, Adolfo Serrate, despite the light rain, left his house early in order to work his cornfield. Around 9:20 a.m. Serrate decided to take a much needed smoke break. As he exhaled the smoke he looked towards the sky and was surprised to see a round object that was descending quickly and silently towards the nearby fields. Scared, Serrate hid among the cornfield and the edge of the field. He was concerned he 'would be

kidnapped' since his cousin had mysteriously disappeared in the same area 2 years before. Crouching low to the ground he watched the round craft descend to the ground. It gently landed on some grass on a sort of landing gear that the witness compared to 'skates." The surface of the object was very smooth, without any visible details and it gave Serrate the impression that it was colored in different tones of green, almost as if camouflaged.

He estimated the object to be as large as a passenger car. Breathlessly he noticed that the object had a transparent glass section, which he interpreted as the control cabin. The strange craft did not have any wings or rotors or wheels like he was familiar with when he was aircraft mechanic in the service. To Serrate it resembled the top of a turtle. An aperture like that of a sliding door became visible, and from where he was, about 60 to 80 meters away, he could not clearly see the interior. However he was able to see what appeared to be a human-like figure come out of the opening. He was not able to see any facial features since the figure was completely covered in a suit the same color as the object. The figure's head and face were covered with a sort of gas mask black in color. The individual walked around the object and on several occasions seemed to bend down and pluck some of the malanga and calabaza roots on the field. The figure then walked behind the object and when he came around again he leaned against the hull of the object next to the opening. He then made a sort of gesture with his head towards the inside of the object perhaps communicating with other unseen occupants. Moments later he boarded the object and the door closed, without leaving any signs that it was actually there. Serrate remained watching the scene not knowing what to expect next. Suddenly he felt a sort of air wave or shock on his face, which also disturbed the cornstalks and other small plants around him, at the same time he could see the UFO ascending vertically into the sky, without emitting any fire, smoke and making any noise.

At about 50 feet in height it stopped briefly and at this point Serrate saw what appeared to be a thin blue flame coming out from an unknown source on the top of the object. The object then took off in a horizontal flight towards the south towards the nearby National Highway, still completely silent. Immediately the witness ran home and notified the police, afraid that he had seen an "enemy aircraft engaged in sabotage." Later investigators interviewed other locals who reported seeing the same or similar craft in flight. At the site they found physical evidence, including footprints,

and leaves scorched black by the object's propulsion system. The material was reportedly turned over to the Cuban Academy of Sciences. (47)



Pre-Arnold Corner

During the war summer of 1944 in the village of Vasilievka, Dnepropetrovsk Province, Ukraine (USSR at the time) one day the 8-year old witness V. I. Nohavov was standing outside when he suddenly looked up and was paralyzed with fear when he saw an object low in the clouds, not to far from the ground. A door was opened on the object and a beautiful woman was then standing on the doorway. She had flowing hair, and was dressed in a grayish suit and was looking directly at the witness. The alien woman had a severe and determined strong-willed face. They looked at each other for an indefinite period of time since the witness appears to have lost all sense of time. He could only remember that he could not stop looking at her, he felt as if hypnotized. Moments later the door closed and the object disappeared. (48)

Sometime during 1940 in the village of Leninabad, Tajikistan (USSR at the time) Lubov I. Vasilenko, a 9-year old girl at the time, reported (in 1985) that she saw an alien spacecraft land not far from her house and two alien "cosmonauts" emerge from it and approached their house. Both humanoids, according to Vasilenko, looked remotely like humans, and spoke to her father Ivan Kayokin." The aliens then made him take a kind of an oath not to talk about the content of their conversation. The aliens then looked at him and said, "Look Ivan, if you keep your word and believe us, then your daughter would tell people about this encounter, but only 43 years from

now.” Unfortunately Kayokin never was able to divulged what he spoke about with the aliens since he was reported missing during the 2nd World War and was never found. (49)

THE FRINGE



The Owlman in Poland?

On August 7 1991 at around 6:20 a.m. in the village of Niemojkow, Poland, the witness was bringing his cow to the pasture when he spotted something ‘shiny’ in a field. When he approached the ‘object’ it turned to be something that resembled a large bipedal winged ‘owl’ like creature, whose body and head were covered in silvery tear-shaped ‘tiles.’ The figure was in constant motion moving left to right, apparently floating just above the ground but always remaining in front of the witness. It also possessed huge round eyes with round pupils which seemed to ‘rotate’ clockwise. In between its eyes it had a 5–8cm protrusion resembling a nose or ‘beak’. The witness observed the strange creature for about 5 minutes. The strange figure eventually rose up into the air and disappeared towards Myszkowice. It was reported that there were other witnesses to the event. (50)

Underwater dweller in The Sea of Azov

One day in the summer of 1990 at an unspecified location bordering the Sea of Azov, Russia, a 12-year old boy was wading up to his waist in the waters in this body of water, which has numerous sandbars and it's not that deep. He was wading above a sandbank which suddenly gave way and he fell into a deep pit in the water. He then dove deeper attempting to access his location and to look around when he spotted a small greenish "man." The dwarf-like entity was sitting at the bottom of the ocean. His eyes were disproportional to his face; they were very big and bulging. Both stared at each other in amazement. The alien dwarf waved his hand and accidentally scratched the boy's belly with its long nails. They both then moved away from each other in different directions, the alien towards deeper waters and the boy to the surface, the boy then ran home fearing for his life and never returned to the water for the rest of the year. He never saw the entity again. (51)
